### VENDOR APPLICATION INFORMATION:

- Deadline: Wednesday, November 1, 2023.
- Booth Fees: (All booth fees are non-refundable) ○ Vendor Booth (Tent & Boutique Trailer) – Single 10x10 - \$75, Double 10x20 - \$150, Triple 10x30 - \$225 ○ Winery (Tent & Boutique Trailer) – Single 10x10 - \$100, Double 10x20 - \$200, Triple 10x30 - \$300 ○ Food (Tent/Truck/Trailer) - \$150
  - Electrical Outlet - \$25/outlet (**110v/20amp**) – *limited quantity available*
- Payment Form: Credit Card, Check, Cashier's Check or Money Order. **Cash Not Accepted.**
- Payable: Bertram Chamber of Commerce. Online payment through Square (link provided upon acceptance) □ Sales Tax: Vendors are required to collect Texas Sales Tax (Bertram's Tax Rate is 8.25%)

### DIGITAL IMAGES

- Vendor must submit at least one photo that conveys what they are selling, what booth set up looks like
- If a booth image is not available, submit an image taken of a grouping representing the works to be exhibited.

### RULES/REGULATIONS

- Booths must be staffed and open to the public on Saturday from 9:30 am to 4:00 pm.
- All booths will be located on Vaughan & Grange Streets (each booth space will be 10x10) □ The roads will be blocked to through traffic Saturday from 6 am to 5 pm □ Load-in times **MUST BE STRICTLY ADHERED TO. Hours 6:00 am – 9:00AM.**
- Once vehicles are unloaded proceed to move your vehicle to the vendor parking area. **All vehicles must be out of festival area (unless part of booth) No later than 9:00AM.**
- The festival ends on Saturday at 4:00 pm. **No booth breakdown will be permitted before 4:00 pm**
- Vendors must provide weighted tents or awnings, tables, shelves or whatever is needed for item display. This is an outdoor festival and will be held rain or shine. Regardless of weather conditions vendors will be expected to participate.
- Vendors are responsible for all "booth" set-up and take down of merchandise, displays and tents/awnings. Each vendor is responsible for assuring that all items in their booth are well secured in the event of weather, i.e. wind, rain, etc., and that **weights must be used to secure all corners** and parts of booth (tables, shelves, hanging racks, etc.) so as not to blow into or damage another vendors booth and merchandise. **Please note windy conditions are normal**
- **No water hook-ups available.** Make arrangements to bring your own potable water.
- **You may not take your vehicle to your booth during the festival, even to replenish stock. Cart in only! No exceptions! Courtesy Golf carts will be staffed for your convenience.**
- Vendor is responsible for cleaning their own area, disposing of trash in the appropriate areas and returning the festival area to its original condition.
- Each vendor will be responsible to obtain and display all permits/certificates as appropriate. Vendor must file documents and taxes as required by city, state and federal regulations based on their business. The Bertram Sales Tax rate is 8.25% □ Vendors that requested electricity are responsible for their own extension cords for standard 110v outlets.
